#### 10.10 Plenary: Precautionary principle in the EU and the US (Ballroom)

The precautionary principle is about taking preventative policy measures when there is reasonable suspicion of harm, even if scientific evidence is lacking. The EU is widely considered more precautionary in several key policy areas, including consumer policy as well as food and health, and therefore there is wide-spread concern regarding the impact of the TTIP on its ability to regulate in the societal interest. Others argue that regulations in the US frequently apply precaution, but for different areas and policies. The discussion in this plenary will give an overview of the precautionary principle in trade agreements, and how it is used in the EU and the US.
